3. How to apply:-

- i. The eligible and desirous doctors fulfilling the educational qualifications/eligibility conditions should submit their applications(as per Annexure-'A') alongwith one set of self attested copies of relevant documents in support of age, qualifications, attempt certificate, Mark-sheet, Degree, MCI or State Registration(s), EWS/SC/ST/OBC/PWD/Ex-serviceman certificate & experience certificate etc. and 2(two) recent passport size photographs. The candidate who is currently in the employment must bring experience certificate (working certificate) and No Objection certificate (NOC) from the present employer, failing which his/her candidature will be liable to rejection.
- ii. The interview(s) scheduled **on 28-01-2025 & 29-01-2025 from 9.15 a.m.** onwards (after the scrutiny of applications on same date, the eligible candidate's interview will only be taken).
- iii. Aspirants possessing qualification only with registration as on the date of interview will only be considered; those whose result is awaited will not be considered.

4. Terms & Conditions:-

- 1. Candidate should report in the Administration Office situated at 6th Floor of ESIC Model Hospital, Nanda Nagar, Indore from 9.15 A.M. to 11.00 A.M. on the stipulated date. Candidates reporting after 11.00 A.M. will not be entertained for Walk-In-Interview unless valid
- 2. Reservations for other reserved categories will be executed as per existing Central Government Rules.
- 3. Candidates seeking Reservation / Age relaxation benefits under SC/ST/OBC/EWS/PWD/Ex-serviceman category must ensure that they are entitled to such reservation as per eligibility prescribed in the notice and as per the instruction issued by Government of India. They should also be in possession of the certificates in the prescribed format of Govt. of India in support of their claim. Candidates seeking reservation under EWS category, should submit their EWS certificate as prescribed vide Govt. of India, Department of Personnel & Training OM No. 36039/1/2019-Estt.(Res) dated 31-01-2019. Candidates claiming reservation/age relaxation under OBC category should submit their OBC certificate as prescribed vide Govt. of India, Department of Personnel & Training OM No. 36012/22/93-Estt.(SCT) dated 08/09/1993 which is modified vide OM No. 36033/3/2004 Estt. - 4. Interested candidates may appear for the walk-in-interview as per given schedule alongwith their original documents and Xerox copies in support of their date of birth, proof of educational qualification, experience certificate, caste certificate as per Government of India Format, non-creamy layer certificate as per Government of India format in case of OBC. They are advised to appear for interview with duly filled Annexure-'A' which is available on website.
- 5. Private practice of any kind will not be allowed (except for Part Time Specialist/ Super Specialist).
- 6. The number of vacancies/ category-wise vacancies may vary/likely to increase or decrease.
- 7. No TA/DA will be paid to candidates for appearing in the walk-in-interview.
- 8. Application should be submitted for each post separately.

- 9. The Medical Superintendant reserves the right to fill up all or not to fill up any vacancy.
- 10. The Medical Superintendant reserves the right to alter the date or cancel the interview.
- 11. Full-time specialist on contractual basis shall be recruited for a period of 3 years with annual evaluation and term renewed every year based on satisfactory performance. He/She has to sign the contract on a Non Judicial Stamp Paper of Rs. 500/- before joining. The original contract will be with the hospital and its copy will be with candidate. The cost of the Non Judicial Stamp Paper will be borne by the candidate
- 12. The Contractual specialist shall be responsible for all cases undergoing treatment under his supervision in his discipline.
- 13. Full time Contractual Specialists will be entitled for the leave @ 04 days for each month of work on prorate basis in a calendar year. In the event, the specialist prefers not to avail the leave, the same may be encashed to a maximum limit of 30 days/ year.
- 14. Period of contract for part time contractual specialist will be of 1 year from the date of joining or till regular incumbent joins.
- 15. Part time contractual specialist will not be entitled for any kind of leave.
- 16. The selected Contractual specialist/ Super Specialist must have a professional indemnity policy which should cover the period as desired by ESIC in the bid. The policy is mean to cover professional liability falling on them as a result of error and omissions committed by them while rendering professional services. 5. ELIGIBILITY CRITERIA FOR THE POST OF FULL TIME/PART TIME CONTRACTUAL SUPER SPECIALIST

- 1. Upper age limits will be 67 years as on date of interview.
- 2. MBBS and MD/MS/DNB Degree from MCI recognized Medical College/ Institution.
- 3. DM/MCH in respective Super Specialty from MCI recognized Medical College/DNB in concerned super specialty or equivalent.
- 4. Should have registered with MCI or State Medical Council.
- 5. Five years' experience in the concerned specialty after obtaining the First Post Graduate degree. Note:- Qualifications with regard to experience are relaxable at the discretion of the Appointing Authority on recommendation of the Selection Committee in case of candidates otherwise well qualified
- 6. Emoluments and Terms & Conditions
- 7. For Full Time Contractual Super Specialists: Rs. 2,00,000/- (Consolidated remuneration) per month. No other allowances in any form shall be admissible.
- 8. For Part Time Contractual Super Specialists: Rs. 1,00,000/- (Consolidated remuneration) per month for 04 hours per day & 04 days in a week. In addition, Rs. 20,000/- per month for visiting charge in case of an emergency call and Rs. 1200/- for every additional hour beyond 16hours/week. The additional hour of work will be decided by the Medical Superintendent. No other allowances in any form shall be admissible.
- 9. The engagement will be for a period of one year or till regular incumbent joins, whichever is earlier and further on the expiry of the contract, period of tenure may be extended on mutual consent of both the parties on same terms and conditions.
- 10. The Contractual Super Specialist shall be available on call 24x7.
- 11. The Contractual Super Specialist shall be responsible for all cases undergoing treatment under his supervision in that specialty discipline.
- 12. The Selected Contractual Super Specialist must have a professional indemnity policy which should cover the period of contractual engagement. The policy is meant to cover professional liability falling on them as a result of error and omissions committed by them while rendering professional services. The minimum sum assured per annum should be Rs.30 lakh for Anesthesiologists, Cardiac Surgeon, Neuro Surgeons, Plastic Surgeons etc. (2) Rs. 20 lakhs for General Surgeons, Gynecologist, Obstetrician etc. (3) for Physicians Dentists, Radiologists, Pathologists etc. it should be at least of Rs. 10 lakhs. - 13. Selected candidates will have no claim for regularization of services in the Hospital/Medical Institution.
- 14. The Full time Contractual Super Specialist is entitled for the leave @ 04 days for each month of work on a prorata basis in a calendar year. In the event, the Super specialist prefers not to avail the leave; the same may be encashed to a maximum limit of 30 days.
- 15. The Part time Contractual Super Specialist will not be entitled for any kind of leave benefits.
- 16. The appointment is subject to Medical Fitness.
- 17. No TA/DA will be admissible for attending the interview/joining the post.
- 18. The selected Full Time/Part Time Contractual Super Specialist will be required to submit acceptance/consent letter in writing before appearing for Medical examination.
- 19. The appointing authority reserves the right to terminate the appointee anytime even before the tenure without assigning any reason by giving one month notice. Similarly, the engaged person will have to give one month prior notice before resigning or will have to pay an amount equivalent to one month's remuneration in lieu of the notice period.
- 20. The doctors at any time found guilty of any gross misconduct or negligence of his/her duties shall be terminated without any notice or payment in lieu of the notice period.
- 21. Selected candidates will join duty immediately or the date indicated in the offer of appointment/engagement likely to be issued, failing which the offer letter will be treated as cancelled.
- 22. Full time/Part time Contractual Super Specialist has to wear his/her own white coat with name badge during the duty hours.
- 23. He/ She will be required to mark attendance manually as well as AEBAS (Aadhar Enabled Based Bio Metric Attendance System).
- 24.
